A. Introduction

Our Privacy Notice details how [开发者名称](“we”, “us”, or “our”) collects, uses, and discloses the personal data we collect from and about you when you access or use our SnapMaster: Edit and Clean (“App” or “Service”). We suggest you read this Notice carefully and if you do not agree to this Notice, please do not use our App.

B. Data collection and use

The personal data we collect and process may vary, depending on how you use our App:

- Your name and email address.
- IP addresses.
- Activity Information directly related to your use of the App, includes contact list and or photos.
- Usage data includes the pages of our App you visit, the time and date of your visit, the time spent on those pages, unique device identifiers another diagnostic data.
- Device information includes device types and settings, device identifiers (such as IDFA, IDFV for Android, GAID for IOS), browser types, mobile, wireless, operating system versions, another network information (such as internet service provider name, carrier name and signal strength), and application version numbers.

We use your personal data for a variety of business purposes, including:

- To fulfill our contracts with you and provide you with our Services.
- To pursue our legitimate interests such as direct marketing, research, and development (including market research), network and information security.
- To improve, upgrade, or enhance our Service.
- For internal quality control and safety.
- To comply with and enforce legal rights, requirements, agreements, and policies.

C. Disclosure of your data

We disclose your personal data to the following third parties:

- Our company affiliates to support and supplement the Services we provide.
- Our third-party service providers and vendors that assist us with the provision of our Services and process personal data on our behalf, such as IT support.
- Our professional advisors such as tax consulting firms, auditors, accountants, and legal advisors.
- law enforcement or governmental or judicial authorities in relation to the prevention or detection of crime and fraud and for national security purposes.

D. Retention of your data

Where we act as a controller of your personal data, we retain such data until it is no longer necessary to fulfill the purpose it is being used for, as required by applicable laws, or until you ask us to delete it.

E. Security

We take steps to ensure that your data is treated securely and in accordance with this Privacy Notice.

F. Your rights and choices regarding your data

In accordance with applicable law, you may have the right to:

- Access to and portability of personal data about you.
- Request data deletion, anonymization, or blocking of your personal data when processing is based on your consent or when processing is unnecessary, excessive, or noncompliant.
- Request correction of your personal data where it is inaccurate, incomplete, or outdated.
- Withdraw your consent. Please note that your withdrawal will only take effect for future processing, and will not affect the lawfulness of processing before the withdrawal.
